4. Registered Person shall, prior to the Auction, study the information of the Trademarks made available by the Bailiff and on behalf of the person on whose instructions the Trademarks are to be auctioned.

Registered Person is familiar with the fact that the Bailiff must comply with the guidelines and policy rules of the Royal Association of Bailiffs, and furthermore with the laws and regulations applicable in the Netherlands, including in particular the Money Laundering and Terrorist Financing (Prevention) Act (*Wwft*). In connection with this, the Bailiff may be required to report situations or transactions of an unusual nature to the Financial Intelligence Unit - Netherlands or any other body designated for that purpose by legislation. By law, a bailiff may not inform any party, including his client and Registered person(s) of any such report. Registered person declares that he agrees to this.

The Bailiff may also refuse to allow Registered Persons to participate in the Auction if the Registered Person is, or owned and/or controlled by, or affiliated with a person or a group and/or an entity which is subject to (financial) sanctions, whether based on national, European or international sanctions lists.

6. Registered Person declares to have completed the attached UBO statement and/or PEP statement fully and truthfully and also to have the signature of this statement legalised by a notary public, in accordance with the form attached herewith.
